Since 1983, the Children's Trust Fund has allocated more than \$107 million to prevention programs in Missouri, with more than \$6 million allocated in FY25 alone.

GRANTMAKING

CTF re-evaluates child sexual abuse prevention strategy and renews funding

In Fiscal Year 2025, CTF re-evaluated our approach to child sexual abuse prevention with a greater initiator focus in order to address the root causes of abuse.

CTF then released a new cycle of child sexual abuse prevention funding and is excited to partner with the following agencies in fiscal years 2026-2029:



- The Child Advocacy Center of Northeast Missouri
- The Metropolitan Organization Countering Sexual Assault
- · Prevention Consultants of Missouri
- Southeast Missouri Network Against Sexual Violence

For four years starting in fiscal year 2025, the Children's Trust Fund began a new strategic plan. The biggest change to our plan was an acknowledgment that perhaps we had become too "targeted" in how we award funding. We certainly believe in a targeted funding strategy, but we also recognize this does not allow us to support *other* approaches that show promise and impact. As a result of these discussions, CTF awarded up to \$500,000 annually (across four years) for responsive funding to allow for a broader range of agencies and programs to apply.

With this funding, CTF is proud to partner with **The Community**Partnership of Rolla, Father & Families Support Center, Mattie Rhodes

Center, PATCH of Chillicothe, and St. Louis Crisis Nursery.

POLICY & ADVOCACY

MIECHV and MOPPP home visiting contracts transition to CTF from DESE

In the 2025 legislative session, the Missouri General Assembly amended the language in the budget bill to move the Missouri Parenting Partnership Program (MOPPP) and Maternal, Infant, and Early Childhood Home Visiting (MIECHV) to the Children's Trust Fund from the Department of Elementary and Secondary Education.

Home visiting is one of our state's best strategies to improve the wellbeing of Missouri children and families. CTF looks forward to continuing to build the best home visiting system in the nation with our partners.

MOPPP is state-funded, available in all Missouri counties and designed to support families at risk of child-welfare involvement.

MIECHV programs are federally funded home visiting services to select counties that are at the most risk for adverse maternal and child health outcomes.

CTF is excited to connect with and learn from our new home visiting program partners and build upon the existing foundation for home visiting in Missouri.



PUBLIC EDUCATION

CTF releases two additional campaign runs for Something We Agree On in the spring of 2025

This spring, CTF ran our Something We Agree On (SWAO) marketing campaign for child sexual abuse prevention and corporal punishment prevention.

For the first time, CTF prioritized **website traffic and engagement** over raw impressions (views). This strategy was highly successful in the sexual abuse prevention campaign. It received slightly fewer impressions overall but much more engagement than in any previous campaign.

The corporal punishment campaign performed differently. The FY24 campaign was our most successful SWAO campaign run ever. Although FY25 was still successful, it performed slightly below its premier levels.

Sexual Abuse Prevention FY24

- More than 5.9 million impressions
- 18,727 link clicks
- **36,300** engagements

Sexual Abuse Prevention **FY25**

- More than 6 million impressions
- **26,800** link clicks
- **124,000** engagements

Corporal Punishment Prevention FY24

- **46,200** link clicks

- 200,300 engagements

In 2025, both campaign flights reached *younger* and *significantly* more male audiences than any of our previous campaigns, allowing us to have a better balance overall of Missouri parents seeing Something We Agree On. We believe that some of the differences in audience and reception may be due to recent changes to the social media landscape, particularly at Meta (Facebook and Instagram).

CTF completes 1st Something We Agree On mini-grant cycle and releases 2nd cycle, which begin in FY26



In calendar year 2024, CTF tried something new: We released our first round of public education minigrants, and they vastly exceeded our expectations.

From these mini-grants, we have learned that sometimes the best way to spread our message is to let communities do it in their own way. Therefore, CTF is excited to partner with seven agencies - some new, some return partners - on another cycle of public

education mini-grants, which begin in fiscal year 2026:

CTF rebrands license plate donation materials: Join the DRIVE to protect kids now helps fund CTF public education efforts

In fiscal year 2025, CTF phased out of its four-year cycle of Safe Sleep funding. Although CTF still believes in the mission and importance of safe sleep for infants, we feel that our mission can have more impact for all children in other realms, including sexual abuse prevention and home visiting (which often includes safe sleep components).



Therefore, beginning in fiscal year 2026, CTF's license plate donations, which previously funded safe sleep grants, will now fund our public education efforts, including Something We Agree On.

CTF receives \$15 for each marriage license issued in Missouri and \$7 for each certified copy issued.

CTF receives \$5 for each vital record issued by the Missouri Department of Health and Senior Services.

In 1983, CTF became the first tax check-off program on the Missouri State Tax Form.

In 1997, the General Assembly approved CTF's License Plate Program, making CTF the 2nd organization in the nation to have a License Plate Program for Child Abuse Prevention.
